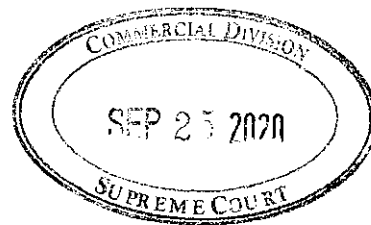

The Claimant/Applicant, **Stephen Price**, being a director of **CABLE & WIRELESS JAMAICA LIMITED**, a company duly incorporated in Jamaica, with Registered Office at **2-6 Carlton Crescent, Kingston 10**, in the Parish of **St. Andrew**, applies to this Honourable Court pursuant to section 130 (2) of the Companies Act for orders/directions that general meetings (which term includes annual and extraordinary general meetings including adjourned or postponed annual or extraordinary general meetings) of Cable & Wireless Jamaica Limited during the years 2020 and 2021 be called, held and conducted in such manner as this Honourable Court thinks fit and, to that end, seeks the following **ORDERS and/or DIRECTIONS THAT:**

1. Notwithstanding the provisions of the Companies Act, the provisions of its Articles of Incorporation or information contained in any notice of a general meeting, information circular or other document that may be or have already been disseminated by Cable & Wireless Jamaica Limited regarding the holding of its general meetings, Cable & Wireless Jamaica Limited may call, hold and conduct

its general meetings during the years 2020 and 2021 in accordance with this order and any general meeting called, held or conducted in accordance with this order shall for all purposes be deemed to be a meeting of the company duly called, held and conducted.

2. In addition to the manner prescribed in the Companies Act and in its Articles of Incorporation, Cable & Wireless Jamaica Limited is permitted, alternatively, to conduct its general meetings during the years 2020 and 2021 by either:
  - a. Conducting a Virtual or Electronic general meeting; or
  - b. Conducting a Hybrid general meeting;

As those processes at a and b above are described by the Companies Office of Jamaica in its published ***“Guidance on Holding Annual General Meetings During Covid-19”***, as updated on April 28, 2020.

3. Cable & Wireless Jamaica Limited is permitted to provide its shareholders at any time during the years 2020 and 2021 with notices of general meetings, resolutions, draft resolutions proposed to be passed, circulars, proxy forms, financial statements, and any other documents necessary or relevant to the conduct of a general meeting by one or more of the following means: electronic mail, pre-paid mail, posting to its website, publishing in the daily newspapers links that can be utilized to view and obtain a copy of the documents.
4. Any notice or document delivered or made available in accordance with this order shall satisfy all requirements for serving documents for a general meeting or laying such documents before the company in general meeting notwithstanding any provision to the contrary in the Companies Act or the Articles of Incorporation of Cable & Wireless Jamaica Limited.
5. Any vote in a general meeting may be made entirely by Electronic means made available for that purpose. Accordingly, where a general meeting is held in accordance with this Order, voting, whether by poll or “show of hands” will allow a

member or proxy or representative thereof attending by Electronic means to cast a vote live during the general meeting orally or *via* Electronic means.

6. The failure or inability of a shareholder to attend or remain in a general meeting held in accordance with paragraph 2 above shall not constitute a defect in the calling of the general meeting and shall not invalidate any resolutions passed or proceedings taken at that general meeting.
7. Liberty to apply is granted to any director or shareholder of Cable & Wireless Jamaica Limited.
8. The Applicant's attorneys-at-Law are to prepare and file this order.
9. Such further or other relief as this Honourable Court deems appropriate or which may be necessary to give effect to the orders sought.

**The Applicant seeks the orders on the following grounds:**

- a. The provisions for physical distancing and other protocols necessary for individual health and safety during the subsistence of the SARS-CoV-2 (Coronavirus COVID-19) ("Covid-19") pandemic may render it impracticable for Cable & Wireless Jamaica Limited to hold its general meetings in the manner in which those meetings are ordinarily held or to conduct those meetings in the manner prescribed in the Companies Act or in the company's Articles of Incorporation.
- b. Although it does not expressly prohibit them, legal opinions differ on whether or not the Companies Act permits the holding of electronic or hybrid general meetings.
- c. Default in holding an Annual General Meeting in accordance with section 126 of the Companies Act makes the company and every officer of the company who is in default liable to a fine.
- d. Default in laying before the company in general meeting at least once in every calendar year a profit and loss account and a balance sheet as at the date to which the profit and loss account is made up (together with a

directors' report with respect to the state of the company's affairs, etc.) in accordance with section 145 of the Companies Act renders the directors liable on summary conviction before a Parish Court Judge to imprisonment or to a fine.

**The Applicant certifies that he** believes the facts stated in this Fixed Date Claim Form are true.

You should complete the form of Acknowledgement of Service served on you with this Claim Form and deliver it to the registry (address below) so that they receive it within FOURTEEN days of service of this Claim Form on you. The form of Acknowledgement of

Service may be completed by you or an Attorney-at-Law, acting for you. See Rules 9.3 (1) and 9.4(3).

You should consider obtaining legal advice with regard to this claim. See notes in form 2A served with this Claim Form.

This Fixed Date Claim Form has no validity if it is not served within six months of the date below unless it is accompanied by an order extending that time. See Rule 8.14(1)

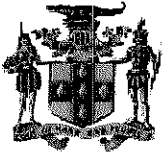

## **PRESCRIBED NOTES FOR DEFENDANT**

### **Form 2A [Rule 8.16(1)(c)]**

This Form is important.

When you get this document you should consider getting legal advice.

The Claimants are seeking an order from the court as set out in the Fixed Date Claim Form on the basis of the facts or evidence set out in the Affidavit which was served with it. The Claimants will not be entitled to enter judgment against you without a hearing.

You may:

A. Admit the Claim

If so, you should complete and return the form of Acknowledgement of Service to the registry within **FOURTEEN DAYS** stating this. You may attend the first hearing if you wish to do so.

B. Dispute the Claim

If so, you should complete and return the form of Acknowledgement of Service as under A. You should also file at the registry and serve on the Claimant's Attorneys-at-Law (or the Claimant if it has no Attorneys-at-Law):

- a. an Affidavit in answer if the Fixed Date Claim Form was accompanied by an Affidavit sworn by or on behalf of the Claimant. See Rule 8.8 (2)

within **TWENTY-EIGHT DAYS** of the day on which the Fixed Date Claim Form was served on you. Your Affidavit must set out briefly **ALL** the facts on which you will rely to dispute the claim made against you.

C. Make a claim against the Claimant

If so, you should complete and return the form of Acknowledgement of Service as under A. You must file a Particulars of Claim (a counterclaim) setting out full details of what you claim against the Claimants and the facts on which you will rely. This must be done within **FORTY-TWO DAYS** of the date on which the Fixed Date Claim Form was served on you. The Particulars of Claim should set out **ALL** the facts on which you rely in disputing any part of the Claimants' claim against you.

**YOU SHOULD ALSO ATTEND THE FIRST HEARING. IF YOU DO NOT THE JUDGE MAY DEAL WITH THE CLAIM IN YOUR ABSENCE.**
